

**GUIDELINES & ESSENTIAL INFORMATION** 

## **GENERAL RULES**

- 1. "Online" means controlled by or connected to a computer with the help of Microsoft teams.
- 2. "Organizers" means the Moot Court Committee and members of Organizing Committee for the International Online Moot Court Competition.
- 3. "Participating Team" means the team, which has registered itself for the competition.
- 4. "Participants" means the speakers & the researcher of the Participating Team.
- 5. "Video Conference" means a live, visual connection between two or more people residing in separate locations for the purpose of communication.
- 6. All the rules are only inclusive and not exhaustive for the competition.
- 7. Rules should be strictly adhered to. Any deviation there from would attract disqualification or other penalties mentioned subsequently.
- All decisions by the Organizers in case of any disputes/ doubts etc. will be final.
- 9. Imposition of penalties including disqualification rests solely with the Organizers in case of failure to comply with the rule(s) and deadline(s).

## DRESS CODE

The dress code for the competition shall be Formal Attire/uniform for both male and female participants.

## **ELIGIBILITY**

Undergraduate students pursuing three- or five-year courses of LL.B. degree /LLM degree from any Law School/College/University recognized by the Bar Council of India.

## **LANGUAGE**

The official working language of the Competition shall be English.

### **TEAM COMPOSITION**

One team, comprising of a maximum of three (3) members, per team, shall be eligible to participate in the Competition, subject to completion of Registration formalities.

From a team of two persons, both the member has to present the case and any one of the member shall be the researcher, and for three person teams two participants have to appear as the speaker and one as researcher.

Each team should prepare one Memorial from both the side.

## LAST DATE OF REGISTRATION

Teams must confirm their participation by filling up the online Registration Form completely by December 5th 2020.

Every Participating Team will be allotted a team code which will be communicated in due time via email. In case of any changes in the team composition, in terms of the members, the same must be officially conveyed to the Organizers in due time.

- The event will be conducted online via Microsoft Teams

- Participation will be First Come First Serve Basis
- The teams will be provided with a Code

## **RULES FOR CLIENT COUNSELLING**

## 1. Team Composition

 The team should consist of 2 participants. Both the participants should be law students pursuing 5 Year or 3 Year Law Course and LL.M. Participants must wear formal attire.

### 2. Competition Format

There will be three rounds of Counselling Session

- Preliminary Round
- Semi Finals
- Finals

Winners in each round with Top Scores will proceed to the next rounds.

## Consultation

This period should be used by the participant for inter alia consultation with the client during which

participants are expected to derive the relevant information, outline problem, find client's expectation and propose solutions to resolve the problem.

### **Post Consultation**

In the post consultation period, the participants may talk to each other loudly so as to be audible to the judges. Participants should summarize the discussion/interview, indicate the scope of legal work that can be undertaken and the legal issues that should be researched upon.

### Critique

After the Post-Consultation round, the judges may question the participants on the matters discussed by the participants or the client during the consultation or post-consultation period.


