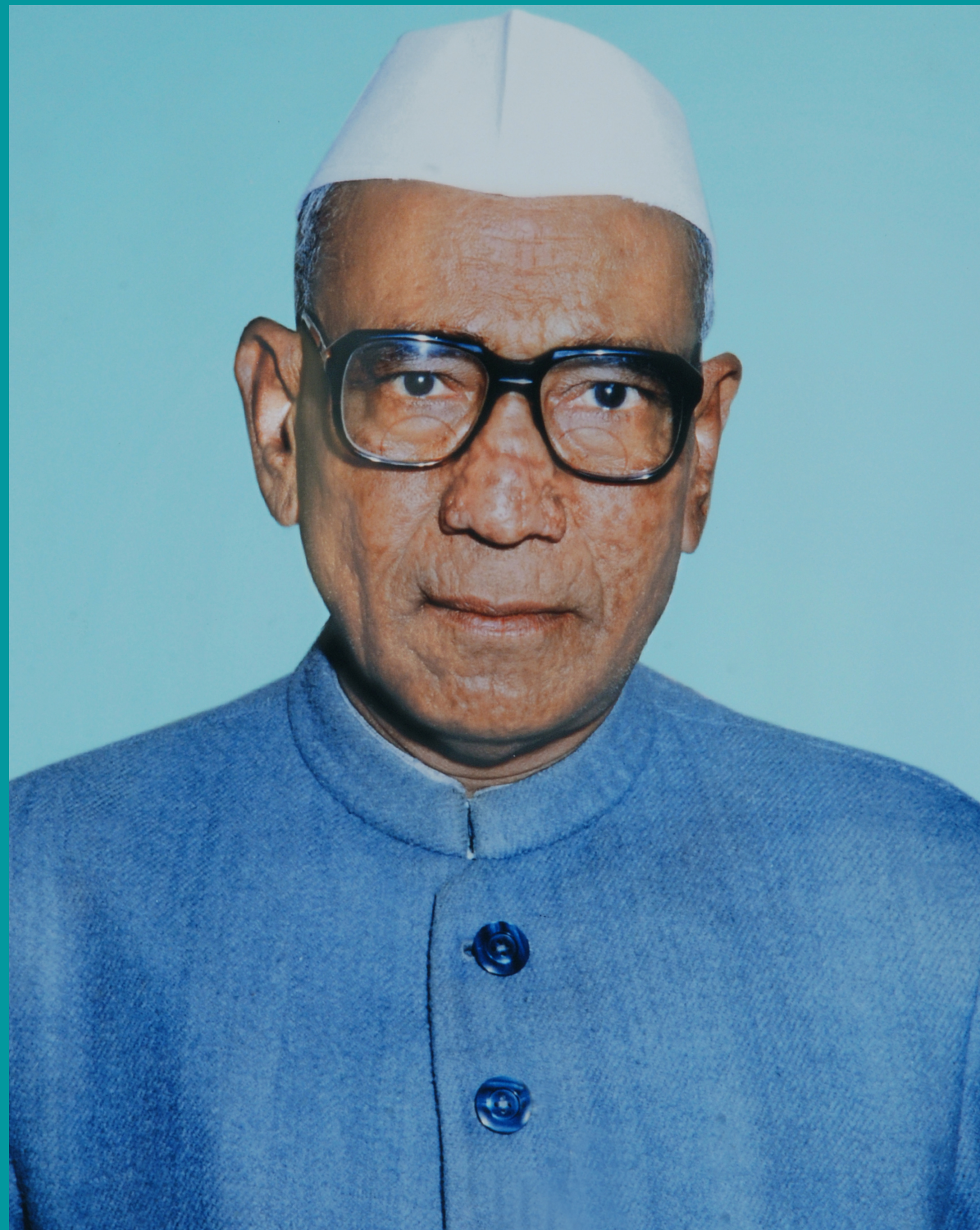

The first edition of the competition was organised back in 2018, which saw a huge success with the participation of law enthusiasts from all across the country. Through this competition, the society aims at providing knowledge and advancement in the area of legal literature and seeks to encourage an intellectual discussion among the students.

Eligibility

Any student pursuing any under graduate or post graduate degree in any discipline, from a recognised University/College in India.

Topics

Authors are free to write on any one of the topics mentioned below:

1. Critique: Indian Foreign Policy during Covid-19 pandemic.
2. Does contempt conviction threaten free speech in India?

Submission Guidelines

- The Article must be in English language only and the submission shall be in Microsoft Word (.doc or .docx format).
- Co-authorship allowed up to a maximum of two authors.

- Only one submission is allowed per author/team. Submissions, both as co-author and single author, will be treated multiple submissions will be disqualified as an entry to the competition.
- There should not be any form of identification mark such as the name of the author, University/College name etc. on the article. Any form of identification will lead to disqualification.
- The Article must contain an abstract of not more than 300 words including keywords.
- The word limit of the article should be 2000-3000 words, excluding footnotes and abstract.
- The write-ups shall have no plagiarism and only original work that have not been published elsewhere and have not been submitted to any other organization are to be submitted.

Formatting Criteria

- Main Body: Font: Times New Roman, Font Size - 12, Line Spacing - 1.5 and Alignment - Justified.
- Footnotes: Font: Times New Roman, Font Size - 10, Line Spacing - 1.0 and Alignment - Justified.
- Margins should be 1 inch or 2.54 cm on all sides.
- The participants shall follow the Harvard Bluebook 20th Edition as the mode of Citation.

Submission Procedure

- There is no registration fee for this competition.
- The participants are required to submit the Article via email to glcleadershipsummit@gmail.com with the subject title "2nd P.N. Agrawal AWC_Submission".
- The participants are required to mention their Name, Year of Study, Degree, Institution Name and Contact details in the email body and not elsewhere.

- Please maintain due diligence while filling the details. The credentials of participants will be checked for successful submission.

Rewards

The top 3 articles will be awarded a cash prize of:

- First Prize - Cash reward of INR 6,000
- Second Prize - Cash reward of INR 4,000
- Third Prize - Cash reward of INR 2,000

In addition, the articles of the First and Second Prize winners shall be published in the first issue of the official journal of the GLCMUN Society "***La Politique***", and they will be awarded a publication certificate as well.

All the participants will be awarded a participation certificate.

Evaluation Criteria

A Selection Committee shall be constituted to review all the Articles submitted by the Participants and shall choose the Top 10 Articles. Out of those 10 articles, a prominent Legal luminary shall review and select the Top 3 Articles.

The decision of the Selection Committee shall be final and binding.

- Tentative date of declaration of results – August 08, 2021 at the closing ceremony of GLC National Leadership Summit'21.
