#### LINCOLN-DOUGLAS DEBATE SPEAKING FORMAT: -

#### **Preliminary Rounds**

#### The Speaking order and times in LD debate are:

- Affirmative Constructive (AC) 3 minutes
- Cross-Examination of the Affirmative by the Negative 1 minute
- Negative Constructive (NC) 3 minutes
- Cross-Examination of the Negative by the Affirmative 1 minute

#### **Preparation Time:**

Preparation time is the time you get in between speeches/cross-examination to prepare a rebuttal against your opponent and defense of your arguments.

Prep time: 3 minutes

- 1st Affirmative Rebuttal (1AR): 1 Minute
- Negative Rebuttal (NR) 2 minutes
- 2nd Affirmative Rebuttal (2AR): 1 Minute

#### **Semi-Final and Final Rounds**

The Speaking order and times in LD debate are:

- Affirmative Constructive (AC) 6 minutes
- Cross-Examination of the Affirmative by the Negative
   3 minutes
- Negative Constructive (NC) 7 minutes
- Cross-Examination of the Negative by the Affirmative
   3 minutes

#### **Preparation Time:**

Preparation time is the time you get in between speeches/cross-examination to prepare a rebuttal against your opponent and defense of your arguments.

#### Prep time: 4 minutes

- 1st Affirmative Rebuttal (1AR) 4 minutes
- Negative Rebuttal (NR) 6 minutes
- 2nd Affirmative Rebuttal (2AR) 3 minutes

(Note: The Time Limits and Rounds will be changed for Elimination Rounds)

#### The topic for the Competition -

- **Preliminary round** Should 50 percent CAP on reservation be diluted?
- Semi-final and final round Should the Uniform Civil Code be implemented in India?

#### **ELIGIBILITY: -**

This competition is an open Inter-college competition for students pursuing an undergraduate course.
