


CONFERENCE THEME:

Ensuring basic human rights of the vulnerable section of society are the cardinal principles of rule of law. The most affected and vulnerable section of the society is children, not to mention their plight during internal disturbances, violence and conflict-like situations. One of the challenges the contemporary world faces today is ensuring the basic human rights of children. The International Human Rights regime relating to children as dealt under the UNCRC is inclusive of the concerns of the international community to address the rights of children. However, there is a need to verify whether there is compliance with international obligations by the governments. The increasing pattern of human rights abuses and exploitation of children in the form of child labour, drug abuse, sexual exploitation, trafficking, pornography, etc., is worrisome. There are national legislations in place to address these issues in India. However, there is a need to deliberate upon the efficiency of the existing legal system to deal with issues relating to violation of child rights. It is pertinent to note that the worldwide spread of COVID-19 has affected children and their rights which are guaranteed under various international instruments significantly and the need to explore the legal effects and efficiency of these laws becomes the need of the hour.

Keeping in mind the deliberations and growing concerns of Child Rights, this One day E- Conference will provide a platform to the scholars, students, academicians, and other luminaries to deliberate upon the pressing issues to assess and take stock of the protection of child rights regime under the UNCRC as well as under various laws, statutes, policies and schemes being in implementation in India.

SUBMISSION AND PRESENTATION GUIDELINES:

1. Submission must include.
 - i. Cover page
 - ii. Abstract (Word Limit: 300-500 words)
 - iii. Full Paper (Word Limit: 3000-6000 words)
 - iv. The Abstract and the Full paper must be submitted in:
 - a. Font: Times New Roman (including footnotes)
 - b. Font size: '12' on an A4 size paper
 - c. Line Spacing: 1.5
 - d. Text alignment must be justified.
 - e. Footnote should follow the uniform style of citation "Bluebook 20th Edition".
 - f. Font size '10' is to be maintained for Footnotes.
2. The Cover page shall consist of the following details: Title of the Paper, Name of the author(s), Official designation/institutional details, Address, E-mail Id and Contact details of the Author(s).
3. The subject of E-mail for submission of Abstract must be "National Conference - Submission of Abstract & Cover Page" and of Full Paper must be "National Conference: Submission of Full Paper".
4. The paper must be emailed to: converse@slsh.edu.in
5. All the participants have to present their research paper before the esteemed panel.
6. Author(s): A maximum of two authors are permitted per paper.

GUIDELINES FOR PAPER PRESENTATION:

- The sessions will be grouped according to the theme of the paper. Each presenter will be given 10 minutes for the presentation of the paper.
- An open discussion shall be conducted after presentation of each paper.
- The paper presenters can make use of any suitable mode of presentation. It shall be upon the discretion of the author(s) to make use of presentation tools such as PowerPoint, Prezi etc.
