# RULES & REGULATIONS OF IOTH RCL NATIONAL MOOT COURT

### 1. DEFINITIONS:

These rules are to be called, the Rules for 10th Rayat College of Law National Moot Court Competition, 2022. Whereas, Organizer means Rayat College of Law, Railmajra (Ropar Campus).

## 2. ELIGIBILITY FOR PARTICIPATION:

The Colleges/ Universities/ Institutes pursuing with LL.B (Five Year or Three Year Degree Course) in the current academic year are eligible to participate in this competition. However, only one team per university/institution shall be eligible to participate.

### 3. TEAM COMPOSITION:

- The participating College/ University/ Institute shall nominate one team consisting of three students for the competition.
- Each team shall comprise of three students (two Speakers and one Researcher).
- An observer may accompany the team but no certificate shall be provided to him/her.
- In case of any contingency, the researcher may substitute the speaker only with the prior permission of the organizer.

### 4. DRESS CODE:

Participants are required to adhere to the following dress code while present in any court room during the competition:

### LADIES:

White shirt and black pant/black skirt along with black tie, black coat and black shoes.

### **GENTLEMEN:**

White shirt, black trousers, black tie along with black coat and black shoes.

\*Strict adherence to the dress code is solicited. Failure will result in disqualification.

### 5. REGISTRATION:

- Registration Form has been annexed at the end of the brochure, the participating teams are required to completely fill the respective form, along with the signatures of the Principal or Head of the College/University/Institute.
- Online Registration shall also be done via link mentioned below.

- Registration Fees: INR 4500
- Payment of the Registration Fees shall be done through Bank Transaction. Bank details are as follows:

- The Payment receipt of the Registration Fees shall be attached to the online registration form.
- Hard Copies of the Registration Form shall be carried by the team members along with the registration form (stamped and signed by the authorities)
- Last date for registration: September 24,2022.
- Participation for the competition is strictly by registration.

## 6. SUBMISSION OF MEMORIAL:

- The participating teams must submit soft copiy of the memorial prepared from both the sides, i.e., "for" and "against" according to the proposition by October 2, 2022.
- The participants must send soft copies of the Memorial at rclmootcourt2016@gmail.com by October 2, 2022.
- Teams are required to bring 6 copies of the memorial along with them.
- Team Codes shall be provided to the participating teams after they
  register themselves online. And the Codes shall be mentioned on the TopRight Corner of the memorials.
- Copies and Documents submitted shall be the property of the organization.

## GUIDELINES FOR FORMATTING

- 1.Memorial or counter-memorial shall not be more than 32 typed pages (A4Size), which consists of the format stated below.
- 2. The body of the memorial must be:
- i) Double line-spaced
- ii) One inch margin on both sides
- iii) Font size 12 (Times New Roman)
- 3. The participating teams are required to prepare written submission/Memorials from both the sides, total 6 copies of the memorials will be required to be submitted.
- 4. The text of footnotes may be single line spaced.

  The font size of the footnotes must be 2 points less than the text font.
- 5.Quotations of sources outside of the memorial of 50 words or more in any part of the memorial shall be block quoted and must be single spaced.
- 6. Name of the college and participants should not be written on the memorial. Only the Tem Codes shall be mentioned.
- 7. The cover page of the memorial prepared "for" shall be in Blue, and the memorial prepared "against" shall be in Red.
- 8. The Table of Contents, Index of Authorities and Case Title are not included in the 32 typed pages limit.
- 9. Memorials and the oral submissions must be prepared and presented in English only.
- \*\*\* the memorial for prosecution shall have blue cover page and memorial for the defence shall have red cover page.

## 7. CONTENT OF MEMORIALS:

The Memorial shall consist of the following parts:

- · Cover page
- · Table of contents
- · Index of authorities
- · Statement of Jurisdiction
- · Statement of issues/charge/law points
- · Statement of facts
- Summary of pleadings
- · Body of pleadings
- · Prayer
- Exhibits/ Appendices (Optional)
- Verification

## 8. SCORING PATTERN:

The assessment of the teams during the Moot Court Competition shall be out of maximum of 100 Marks set out as follows:

## 9. ROUNDS:

There will be three rounds in total i.e.,

- PRELIMINARY ROUND OF ARGUMENTS
- · SEMI-FINALS
- THE FINALS

## PRELIMINARY ROUND

- · Each team shall have two pre appointed speakers for each round.
- · The same speakers shall represent the team in all the rounds.
- The team that will argue first will be decided through a draw of lots.
- Each team will get a total of 20 minutes to present their case and which shall include the time for 'rebuttal' and 'Sur-rebuttal'.
- Any extension of time beyond the specified period shall be subject to the discretion of the judges.
- The division of time between the speakers is the discretion of the team members,
   subject to a minimum of 5 minutes for one speaker.
- It is mandatory for both the speakers to present their case in a comprehensive manner.
- · Memorials will not be exchanged for this round.
- The assessment will be based on the scoring pattern provided herein.
- Each team will be presenting from both the sides i.e., "for" and "against". It is not
  mandatory that the teams will be competing against the same team.
- · This will be an elimination round. The decision of the sitting judges will be final
- Top four teams will qualify for the Semi-Final round.
- In the case of a tie, combined total marks of the preliminary round shall be considered. The team with the higher score will advance to the Semi-Finals. If the situation still persists, then it would be resolved by considering the memorial scores.



## SEMI-FINAL ROUND

- · The top four teams will qualify for the semi final round.
- The team to argue first shall be decided through a draw of lots.
- Each team will get a total of 25 minutes to present their case which shall include
  the time for 'rebuttal' and 'Sur-rebuttal'. Any extension of time beyond the
  specified period shall be subject to the discretion of the judges.
- The division of time between the speakers is the discretion of the team members,
   subject to a minimum of 10 minutes for one speaker.
- It is mandatory for both the speakers to present their case in a comprehensive manner.
- Memorials will not be exchanged for this round.
- The decision of the judges as to the marks allotted to any team shall be final.
- · The two winning teams from semi-final round will make it to the final.



## FINAL ROUND

- The team that will argue first shall be decided through a draw of lots.
- Each team shall get a total of 30 minutes to present their case. This time will include the time for 'rebuttal' and 'Sur-rebuttal'.
- The division of time between the speakers is the discretion of the team members, subject to a maximum of 15 minutes for one speaker.
- The memorials for this round will be exchanged as soon as the result of the semifinals is declared.
- In case of any tie, the decision of the judges shall be final.

## 10. IMPORTANT GUIDELINES AND PENALTIES:

- 1. Participants are expected to observe a proper dress code and make their own arrangements for coats, ties.
- 2. Students shall not interact with the judges or reveal their identities or the identity of their respective college. Any such attempt shall result in instant disqualification. Teams will identify themselves to the judges only by the codes given to them at the time of submission of Memorials.
- 3. The language of the court shall be English.
- 4. The court will follow its own rules of procedure within the framework of accepted norms of judicial practice. On questions of doubt or dispute in the matter of procedure of facts, the decision of the court shall be Final.
- 5. Every team must maintain complete dignity and decorum in the Courtroom. Inappropriate behavior in the Courtroom or blatant disregard for the procedures will result in instant disqualification or defaulting team will be incurred a penalty of 5 points, as per the decision of the presenting judges.
- 6. Speakers shall not be allowed to pass annexure to the judges; instead the teams may make a set of compendium of annexure that shall be given to the judges before the commencement of proceedings.
- 7. Scouting in any manner is strictly prohibited.
- 8. No team member or person directly associated with any team is permitted to attend any round in which the said team is not participating during preliminary rounds.
- 9. Each participant must possess his/her I-card on the day of the competition.
- 10. Prior information for the hostel facility is solicited.

### IMPLEMENTATION AND INTERPRETATION OF RULES:

- -Regarding competition practice and procedures, the final decision on the interpretation and implementation of rules lies with the organizers.
- -The Organizing Committee reserves the right to amend/change the rules & regulations with prior notice to all registered teams.

## 11. MISCELLEANEOUS:

- Upon completion of the competition, the organizing committee reserves the exclusive right to use the memorials submitted to them, as they deem appropriate.
- The Organizing Committee reserves the right, at its sole discretion, to take appropriate action for any unethical, unprofessional and wrongful conduct during the entire period of the competition.
- Participating teams should carry with them required study or reference materials for their own use during the competition.
- Participating teams shall be expected to maintain the proper decorum of the courtroom during the proceedings and shall conduct themselves in a manner befitting the legal profession.
- The Organizing Committee reserves the right to amend, modify or repeal any of the rules if so required and as they deem appropriate.
   Participating teams shall receive adequate notice of any/all such amendments or modifications to the rules.
- The Organizing Committee shall not be held responsible for any loss or non-delivery of the memorials.

## 12. ACCOMODATION:

- The accommodation for all the participating teams shall be provided on 8th October, 2022 & 9th October, 2022.
- Travel of the teams from outstation and to/from venue of the Competition must be at team's own expense.
- The maximum of two members are allowed to participate in the Competition. No team coaches shall be allowed to accompany the teams or to witness their rounds.
- The participating teams are requested to carry their own set of lock and keys for the accommodation.
- Internet facility shall be provided to the teams at their respective accommodation.
- The teams coming by their own conveyance shall be allowed to park their vehicle on the campus.
- In case any sort of local inconvenience is being faced by the teams they
  can contact the organizers for assistance.
- · Organizer will not be responsible for observer's accommodation.
- Rayat Group of Institutions is a non smoking campus. No participating team shall indulge in smoking, drinking or any other objectionable activities otherwise team shall be disqualified.

## MOOT PROPOSITION

Lakshmi is a 22 year old girl, working as a Secretary in a Private Firm for last 5-6 months and has been earning 8,000/- per month. She belongs to a lower middle class family of Bassi in Punjab. Her family consists of her father who is working as a Security Guard in a private firm; mother is a house-wife and two younger sisters and a younger brother.

In March 2020, due to break out of pandemic COVID-19, she lost her job. On 2nd of May, 2020, all of a sudden when her father was on duty, he got stomach-ache and for that he had to be taken to the hospital, where he was diagnosed with kidney failure and was admitted in private hospital where the daily expenses of treatment were 2000-3000/- approx. After 10 days of treatment, he got infected with Corona due to which his health deteriorated and ultimately he died on 25th May, 2020. All the family savings, jewellery etc. were used in paying the bills of the hospital and in the cremation of her father. Now, being the eldest daughter, the whole responsibility was on the shoulders of Lakshmi, so she tried to look for a new job, but as she was not highly qualified and due to COVID-19 situation, she could not get any job.

One day she received a SMS from a company named "Care and Money Services (CAMSS)", that short-term easy loans without any security and documentation were available at cheaper rates of interest. Now she was in dire need of money, as her mother was also not keeping well after her father's death, she thought of trying her luck, and she called back on the given number on 9th June, 2020. The call was attended by one Mr. Vinay, who represented himself to be the Executive of the company. Lakshmi told him that she had received a message from his number regarding availability of easy loans, to which she was interested and asked for the procedure. Mr. Vinay gave an assurance of help to her and informed her about CAMSS App. and provided her a link to download the same. Lakhmi downloaded the App and when opened it, she came to know about the formalities for loan. The only requirement for loan was Aadhaar Card and she could get a loan upto Rs. 5 lac @ 8.5% p.a. Now she felt happy and relieved that all her problems would be solved.

At first she applied for a loan of 50,000/- for the treatment of her mother for the period of two months, on 12th June, 2020. The Executive, Mr. Vinay, called her for confirmation of bank details, Aadhaar Card, and terms and conditions. Immediately after one day, i.e. 13th June, 2020 the loan amount was credited to her account. Lakshmi repaid this loan amount within two months from the gratuity received after the death of her father. But the family problems along with her mother's illness still persisted. In the meantime she had also developed friendly relations with Vinay, and started discussing family problems with him.

On 16th August, 2020, while talking to Lakshmi on phone, Vinay came to know about Lakshmi's family problems and suggested her to take another loan, and said that as she had repaid the earlier loan on time, she was eligible to get a bigger loan. On asking for the procedure for a loan of 7 lacs, Vinay replied that he would confirm it from his seniors. After two days, Lakshmi contacted Vinay to inquire about her loan status. Vinay replied that the company had denied her loan, as she was not providing any security. Lakshmi urged him to help as he being an insider, can help her to get the loan. Vinay said he will see what he could do.

On 21st August 2020, Vinay called Lakshmi and said that he again tried for getting her loan approved, but the company denied on the same grounds. Lakshmi again requested Vinay to look for some solution to the problem, for which he replied that 'I have an inside news that the Company is looking for someone to advertise for marketing purposes of company's new product'. As she was in dire need of money, she agreed to advertise on believing on Vinay. On getting consent, Vinay asked for some of her photographs and biodata on WhatsApp. She immediately sent her photographs and bio-data to him. In the evening on the same day, Vinay called her back and said that the company has asked for some more photograph in a particular outfit, to which Lakshmi hesitated. But Vinay assured her that he will personally supervise the process of advertisement and also enticed her by saying that if everything went correct, he will help her to get more modeling contracts in future as he had contacts with many modeling agencies. On being influenced by Vinay, on Lakshmi sent the photographs on 1st September, 2020. This time the photographs were sent through an e-mail which was in the name of CAMMS, provided by Vinay.

Thereafter, on the same day Vinay sent her a Contract for Advertisement which was signed by Lakshmi and sent back on the same e-mail on 3rd September, 2020. After one week, through WhatsApp Call, Vinay demanded more bold photographs of Lakshmi and this demand was repetitive. Lakshmi denied to these demands of Vinay. On denial by Lakshmi, on 12th September, 2020, Vinay threatened her of dire consequences, as the Company will take legal action as she was making a breach of the contract. She felt perturbed and thought about it, felt helpless, acceded to his request and sent him the photographs on 14th September, on Vinay's WhatsApp number. Some of her morphed photographs were uploaded on some pornographic prohibited websites. There was no communication between the two for next ten days. In the meantime, on 20th September, one of Lakshmi's friends told her that her photographs were being circulated on prohibited websites. She felt shocked to know this. She immediately called Vinay to inquire about the matter, but Vinay did not respond. She repeatedly called Vinay and after sometime, he picked up the call and Lakshmi talked to him about the whole matter and asked him to help her. Vinay remained silent and disconnected the call. She again called him but he did not respond. Then she sent messages on WhatsApp but Vinay did not reply to any.

On 23rd September, Lakshmi was tensed and thought of contacting one of her friends, Kavita, who was a social worker and narrated the whole story to her. Kavita asked her whether she had signed any type of contract with CAMMS. Then she read the contract again and noticed that some of the terms were not in her favour and realized that she had signed the contract without giving a second thought to it. After this, she immediately called Vinay and questioned him about the terms and conditions of the contract. Vinay replied that she must have read the contract before signing. Then they entered into heated arguments and finally Vinay said in a threatening tone that you will have to comply with all the terms and conditions of the contract.

After two days, Vinay called her to meet at Hotel Shining Star, Patiala at 8 PM and also said that now she had no option but to come. Feeling trapped, Lakshmi went to meet him at the hotel, where Vinay was already present. She begged him to remove her photographs from the websites and also asked to terminate the contract. Vinay got aggressive and said that if she wants to get the contract terminated, she will have to pay him Rs. 10 lac within 15 days, else he will circulate all her photographs on websites. On hearing this, Lakshmi immediately left the place.

After reaching her home, she tried to contact the superiors in CAMMS through the App where she found the address and e-mail to be fake and the contact number was found to be in the name of Vinay. Then she remembered about the e-mail on which she had sent the photographs (provided by Vinay) and sent a complaint against Vinay on the same e-mail but she did not get any revert. Next morning she called Vinay asking him for any other way out, in reply to which he demanded physical favours from her. On hearing this, she got shattered. After 2-3 days she again contacted Kavita, and asked for her help. Kavita suggested that she should immediately file an FIR against Vinay. Finding no other way, on 4th October, 2020, she filed FIR at Police Station, Bassi. After preliminary investigation, police arrested Vinay on 6th October, 2020 and registered a case against him under Sections 420, 354, 354C, 383, 506 of IPC, 1860, Section 6 of The Indecent Representation of Women (Prohibition) Act, 1986, Sections 66A, 66E, 67A of IT Act, 2000. After the completion of investigation, the police filed the charge sheet in the Sessions Court, Fatehgarh Sahib on 25th October, 2020. The charges which were framed against Vinay were:

- 1. Whether Vinay is liable under S. 420 IPC, 1860?
- 2. Whether Vinay is liable under Ss. 354, 354C, 383, 506 of IPC, 1860?
- 3. Whether Vinay is liable under S. 6, The Indecent Representation of Women (Prohibition) Act, 1986?
- 4. Whether Vinay is liable under Ss. 66A, 66E, 67A of IT Act, 2000?

The trial was conducted partly through video conferencing and partly through physical hearing. The court after appraising the evidences and examining the statements of witnesses came to the conclusion that Vinay was not liable under Sections 420, 354, 354C, 383, 506 of IPC and Section 6 of The Indecent Representation of Women (Prohibition) Act, 1986 and is being held liable under Section 66 E, IT Act, 2000. It was established in the Court that Vinay had shared offensive photographs of Lakshmi, which were morphed and uploaded on websites. Hence, the court on 24th July, 2022 awarded him 6 months of imprisonment and 50,000 rupees as fine for an offence under S. 66E, IT Act and acquitted him, from all other charges.

On feeling aggrieved by the decision of the trial court, Lakshmi files an appeal on 26th September, 2022 in the Punjab & Haryana High Court, Chandigarh. Argue on behalf of or against the Appellant.
